Regular Meeting, August 11, 2020

1. Call to Order and Announce a Quorum is Present:

With a quorum of the Commissioners present, Mayor Rod Pavlock called the Regular Meeting of the Orchard City Council to order at 5:00 p.m. on Tuesday, August 11, 2020 in the Council Chambers of the Orchard City Hall, 9714 Kibler, Orchard, Texas.

9. Commissioner Perreault made a motion to approve the July financial statements. Commissioner Supak seconded the motion. Motion passed unanimously.


