Regular Meeting, June 9, 2020

1. Call to Order and Announce a Quorum is Present:

With a quorum of the Commissioners present, Mayor Rod Pavlock called the Regular Meeting of the Orchard City Council to order at 6:00 p.m. on Tuesday, June 9, 2020 in the Council Chambers of the Orchard City Hall, 9714 Kibler, Orchard, Texas.

3. Public Recognition: Brenda Minks, Robert Duncan, and Mark Zapalac

All three spoke about the possible burn ban ordinance and all three were against having a burn ban ordinance.

4. Commissioner Perreault made a motion to approve the minutes of May 12th, 2020 regular meeting. Commissioner Supak seconded the motion. Motion passed unanimously.

5. No action taken on passing the burn ban ordinance.

6. The city has asked Texas Disposal to come pick up the recycling dumpster more often to which they responded they have allotted for the dumpster to be picked up every other month should be more than plenty for the size of Orchard. A suggestion was made that the dumpster be placed in a fence and it be unlocked on weekends for the citizens. The city will look into curb side recycling for the future.

7. No action taken. The City is waiting for a response from the City Attorney as to if we can legally have the park and pavilion for citizen use only.

8. Commissioner Perreault made a motion to purchase an ice machine for the new pavilion (ask Industrial development or OCIA to pay for it). Commissioner Supak seconded the motion. Motion passed unanimously.

9. Mayor Pavlock is currently getting pricing for cameras to be installed at the new pavilion. No action taken.

10. No action taken on changing the water and sewer rates.

11. Commissioner Supak made a motion to amend the current Fence ordinance 122-19 to state that no fence or garden wall can be built past the front corners of a any house. Commissioner Perreault seconded the motion. Motion passed unanimously.

13. Commissioner Supak made a motion to approve the financial statements. Commissioner Perreault seconded the motion. Motion passed unanimously.

Commissioner Perreault made a motion to approve the payment of bills and transfers for the month of May transfer of \$16,071.79 from the general fund savings to the general fund checking which includes a transfer made on 6/1/2020 for \$5,000.00. Commissioner Supak abstained from check numbers 7853 and 7854. Commissioner Supak seconded the motion. Motion passed unanimously.
