Regular Meeting, January 4, 2021

1. Call to Order and Announce a Quorum is Present:

With a quorum of the Commissioners present, Mayor Rod Pavlock called the Regular Meeting of the Orchard City Council to order at 5:04 p.m. on Monday, January 4, 2021 in the Council Chambers of the Orchard City Hall, 9714 Kibler, Orchard, Texas.

3. Public Recognition: None

4. Commissioner Perreault made a motion to approve the minutes of November 10, 2020 meeting. Commissioner Supak seconded the motion. Motion passed unanimously.

5 & 6. A new request for use form was created for the park / pavilion. Went over the recent request for renting the pavilion. In conclusion it was decided that until further notice individuals can not rent the pavilion, only non-profit organizations and they will have to have council approve each event. No one should rent the pavilion until COVID is over.

7. Commissioner Perreault made a motion to approve the amendment to ordinance 98-2012 Nuisance Ordinance; to allow a city employee on private property to make sure everything is up to code.

8. The city is going to look into what needs to be done to mow someone's grass. Write letters to people who are driving through private property such as alley (causing drainage issues).

9. No action taken; a possible solution to the speeding in town is to put more stop signs and /or speed limit signs throughout the town.

10. After the state did a study for Fuelmaxx., within the next two years there will be a red light at the intersection of FM 1489 and HWY 36.

11. No action taken on the budget.


12. Commissioner Perreault made a motion to approve the November and December financial statements. Commissioner Supak seconded the motion. Motion passed unanimously.


