- <u>5.</u> Commissioner Demny made a motion to approve the minutes of the February 28, 2011 special meeting. Mayor Pavlock seconded. Motion passed unanimously.
- **6.** Commissioner Kolafa made a motion to reduce the rental fee to \$100.00 for a fundraiser for Orchard resident Esther Reyes, to be held at the Orchard Community Center. Commissioner Demny seconded. Motion passed unanimously.
- <u>7.</u> After studying the ordinance violation fines, Commissioner Kolafa made a motion to present to out attorney for review a fine to be added to Ordinance No. 005-75 of not more than \$200.00. Commissioner Demny seconded. Motion passed unanimously.
